Life was busy growing our farm and raising our family, so when the boys returned to the farm it provided an opportunity for me to expand my horizons. CALP was great; it allowed me a chance to meet some wonderful people and to grow personally. #### Nationwide Preemption Ban Reintroduced in Congress Colorado Pesticide Applicators

Legislation for a nationwide preemption ban has been reintroduced in Congress. The Protect America's Children from Toxic Pesticides Act (PACTPA) was reintroduced on November 23, 2021. If passed this legislation could have significant impacts on the Pesticide Regulated Community and we encourage industry advocacy on these issues. State News -- The Colorado State Legislature will convene at 10AM on Wednesday, January 12, 2022, for the second regular session of the Seventy-Third General Assembly.Be sure to stay engaged with the different ag-organizations that you are a member of to see what bills need testimony and/or outreach (emails, calls, letters) to legislators.We may see legislation

on limiting or controlling the usage of water rights due to the past water-short years. **Federal News --** A food (safety) fight is beginning to heat up in Washington over salmonella as a group of consumer advocates urge the USDA to label certain strains of salmonella as adulterants, which would make them illegal in meat and poultry. While salmonella is already illegal in the rest of the food supply, tension is growing around the meat and poultry industry as debates continue on the best approach.

Holiday Facts -- A handful of "holiday" candies that we wouldn't have without agriculture are Candy Canes (sugar beets/sugar canes), Carmel Corn (corn crops and sugar), Chocolate Covered Cherries (cherry tree orchards and sugar), and Fudge (cocoa and sugar). Any candy you name needs agriculture!
